ORDER DESIGNATING GRANTOR

Marshall, a private citizen, with respect to designation of a Guardian ad Litem for certain described clients of the Department of Children and Families, and the authorization of such Guardian ad Litem to act in their behalf as the Grantor of the proposed Declaration of Master Trust attached to the Petition and Motion filed with the Court.

The Court, having reviewed the Petition, Motion and Briefs filed with the Court in the instant proceeding, and having reviewed the proposed Master Declaration of Trust, and it further appearing that good cause having been shown, it is hereby

ORDERED AND ADJUDGED as follows:

That Marilyn J. Marshall, Movant herein, is hereby DESIGNATED and APPOINTED by the Court to act as the Guardian ad Litem in this proceeding for the interests of the class of persons described in the Petition and Motion, and in such capacity is further DESIGNATED and APPOINTED by the Court to act as the Grantor of the proposed Declaration of Master Trust filed with the Court as an attachment to the Petition and Motion in the instant proceeding.

That upon the execution of the Declaration of Master Trust, and the filing of the executed original Declaration of Master Trust with the Clerk of this Court, that Marilyn J. Marshall will thereupon be discharged as Guardian ad Litem, having completed the responsibilities granted upon her by this Order.

ORDER PROMULGATING DECLARATION OF MASTER  
TRUST, AND DESIGNATING TRUSTEE

Hearing was held on July 8, 1997, upon the Petition and Motion of Marilyn J. Marshall, designated Grantor, for promulgation of a trust for the benefit of certain beneficiaries specifically described in the Declaration of Master Trust filed with this Court, and designation of trustee thereunder. Present was John [unclear] Marilyn Marshall and Linda [unclear] representing the State of Florida Department of Children and Families, who acknowledged the willingness of the Department to accept the responsibilities of trustee pursuant to Chapter 737, Florida Statutes, and Chapter 96-402, Laws of Florida. The Court having reviewed the Petition and Motion as well as a memorandum of law submitted by the Department, and having reviewed the proposed Declaration of Master Trust, and it further appearing that good cause has been shown, it is hereby

ORDERED AND ADJUDGED as follows:

1. It is ORDERED that the proposed Declaration of Master Trust filed and incorporated herein is hereby PROMULGATED by the Grantor.
2. The State of Florida Department of Children and Families is hereby DESIGNATED as Trustee of said Trust.
3. It is the specific FINDING of this Court that said Master Trust is irrevocable, and the funds in the Master Trust are unavailable to the beneficiaries, their families or assistance groups, and are not subject to the Aid to Families with Dependent Children transfer of assets policy.

4. Marilyn J. Marshall, designated Grantor, is hereby relieved of any further responsibilities in regard to this Trust and to the beneficiaries thereof.
